


### BAXTER COUNTY HISTORICAL SOCIETY 1989 MEETINGS

## New home for an old house

This old "shotgun" house, moved down Hwy. 201 N. last week from the Dr. Doug Marx property on Baxter Lane, is now sitting on the Casey lot at the Baxter County Fairgrounds.


Dr. Marx and his wife Dawn donated the 12x30-foot structure to the Baxter County Historical Society.

It was relocated by the M.C. White Construction Company of Mountain Home, taking about one and a half hours to move.

The design is known as "shotgun" because a shotgun fired through the front door would eject shells through the rear door, which is directly opposite it.

Dr. Jimmy Lowe of the Baxter County Historical Society says the design is reportedly of African origin and came to this area via Louisiana.

The house is at least 60 to 70 years old. View/Davis





Moving the old 'shotgun' home down Main Street are volunteers from the Baxter County Road Department. These volunteers as well as many others helped the Baxter County Historical Society relocate the home next to the Casey house, thus preserving a part of Baxter County history.

Thank you letters from the Baxter County Historical Society were sent to Charles T. Blackburn in appreciation of his involvement in getting the 'shotgun' home donated, Dr. & Mrs. Douglas Marx for donating the home, M.C. White Construction for the use of their equipment, operators, foundation work, and several weeks of planning, Baxter County Judge Joe Dillard for staff and equipment usage. Also an open letter to the Editor of the Baxter Bulletin was printed thanking all who were involved.

Volunteers are encouraged to help in the restoration and decoration of the old 'shotgun' house. Contact Dr. James Lowe if you have any time to spare for this project.

#### THE SHOT GUN HOUSE PRESERVATION

Report by F. Gene Garr, Building Chairman, B.C. Historical Society.

#### MOVING DECISION

When it was learned the owner of the property on which the shot gun home was located planned to tear down the structure the Baxter County Historical Society was approached on preserving it. With the efferts of Charles Blackburn (local realtor, and a member of the Society who had previously lived on the property), the Baxter County Historical Society and owner Dr. Marx, the structure was donated to the Society. This effort began in the summer of 1989.

President James Lowe and members Garvin Carroll, Gene Garr and George McGrath of the Society initially inspected the building on the site and decided that it probably could be moved and elected to solicit expert advise for moving the building. The M.C. White Construction Company was contacted and the Society met several times with their representive Bob Lee.

At the following Historical Society meeting the members voted to support the decision to move the Shot Gun house to the site near the historical Casey House in Mtn. Home. A meeting was set up with Judge Joe Dillard of the Quorum Court of Baxter Co. (Baxter County owns the Casey House) Dr. Lowe, Charles Blackburn and Gene Garr. Judge Dillard offered his cooperation and indorsed our plan. He further agreed to furnish the County's Low Boy Truck and trailor with driver for the move.

It was the decision of the joint participants to seek the relocation by the 1st week in September 1989 thus having it on site by the beginning of the Baxter County Fair.

At a meeting at the Marx farm attended by Mtn. Home Mayor Jim Stevens, Judge Dillard, M.C. White, Dr. James Lowe, Gene Garr, Mrs. Marx and Louise Fleming of the Baxter Bulletin, plans were at that time finalized for the moving.

With the help of M.C. White construction the Society had cross braced the building for moving and agreed to remove a badly deteriorated end porch from the building. September 11, 1989 M.C. White Co. crew prepared the footing for the building at the Casey house site. The following day they raised the building with a large front-end loader machine and loaded and secured it on the County's trailer. On the third day, September 13, 1989, with the cooperation of the State Police, City Police, County Road Department, local utility companies, and the M.C. White Construction Co. the building was relocated to the site prepared at the Casey House property. Upon arrival the White Co. crew lowered the house onto the previously prepared footings. All work by the M.C. White Construction Company as well as the other volunteers was donated.

#### SHOT GUN HOUSE DISCRIPTION

The name Shot Gun House is derived from the fact that if a shot gun was fired through the front door the shot would go out the back door without hitting anything.

The Building is 12' wide by 30' long with a 1/4 pitch gable roof, originally roofed with cedar shake shingles and later covered by Corrugated sheet metal. The structure is a frameless type building constructed of 1" x 12" vertically placed (Yellow?) Pine lumber with 4" and 6" batten strips. The siding is also the interior wall finish. Upon removal of a black tar paper material which covered all interior walls, remnants of a floral wall paper was found. The building is constructed on 8" round pine or cedar sills with 2"x6" floor joists placed 16" Center to Center with 3/4" x 6" Tong and Grove flooring. Nails in general appear to be the common wire type. Old square style nails were also found. Some in a door sill located on the West end and a pair through the wall near the ceiling at the South wall near the East end. The square nails could have been added at a later date after the building was constructed. Windows are single hung 4 pane (12"x14") side hung on hinges in a very crude window casing. The structure is divided by two partitions-one has the traditional door in line with the front and back doors. The other partition appears to have been added later and the doorway is not in the usual "Shot Gun" configuration. During a "Work Day" in October 1989 Society members found that some of the many tacks in the walls in the East room apparently held up some type of fabric-shreds of the material was found under the tack heads.

#### HISTORY OF THE HOUSE

The age of the structure is unknown. Current estimates are from 70 to 100 years old. With 70 years probably being closer to its age. Conversations with several people are still being sought to try to determine its exact history. Mr. J.W. Bryant, a native of the area, related that he lived in this building with his parents and brother in 1945 and 1946 when he returned from his tour of duty in WW II. He mentioned that it was an old structure at that time, he also supports the seventy year old theory.

Dr. Lowe, President of the Baxter County Historical Society reports the design of the house is of African origin and came to this area via Louisiana.

#### PROGRESS

On September 25th, after the building was placed, a meeting of the BCHS was held in the building to decide on a course of action to follow in the preservation of the building. It was mutually agreed that the immediate aim of our efforts should be to secure the building from further damage by the elements and to reconstruct the two end porches that are usually on this type of building. It was further agreed that the interior be cleaned up for possible placing of some type of period furniture or the storing of the Society's relics etc. that it now owns. Some work has been completed to date. 14 window panes were required to be replaced. These were donated by Twin Lakes Glass Co. (for a nominal fee to cut the glass) and by Alan Glass of Mountain Home. The window panes have been installed. Lumber for the framing of the porches was obtained at cost from the local "Meeks" lumber yard. The porch decks have been framed and native old style lumber is being sought for the decking. Upon installation of the decking the roof will be constructed. The BCHS agreed that some of its current funds will be used for the project.

#### OCTOBER 30, 1989

A work day was held October 10, 1989 with several members working on the interior of the building removing nails, tacks and tarpaper from the interior walls. Several members performed landscaping maintenance on the Casey house area including the area around the Shot Gun house. A trash receptacle is being furnished by the RLH Waste Management Company.

Rough sawn native pine lumber was donated and delivered on October 23, 1989 by "Bill" Willett (local contractor) to deck the porches. Decking was completed on the East deck October 27th. Work on the ... West deck was completed October 30th. Roofs over the deck area is the next planned step of the restoration. Most of the material for the roofs is on hand.

#### NOVEMBER 7, 1989

Materials left over on the site from the Casey House restoration will be utilized for the posts and siding for the roof sections of the porches. The roof over the East porch was completed Nov. 3rd, except for the permanent roofing. The permanent roofing is planned to coincide with the reroofing of the building. Reconstruction of the West porch is planned during the week of Nov. 6.

#### BITS AND PIECES

The North Arkansas Community College of Mtn. Home had an Eldershostel program this Spring that had many nonarea and area adults participate. The Baxter County Historical Society's President Dr. James Lowe gave a program on Baxter County history and Ozark Archiology during a dinner which many of the Society members attended. The Eldershostel program was a big success!

Several of the Society members attended an evening tea hosted by Mr. and Mrs. Charles Blackburn for the Alumni of the Mountain Home Baptist College 1891-1933 in the old Girls Dormitory building located at 4th & College Street in September. The Alumni Reunion was attended by members from several states, and is an annual event.



Members of the Baxter County Historical Society unveiled in September 'Historical Marker' signs for the above 1893 College Building during a College Street ribbon cutting ceremony held in celebration of the newly widened College Street. Hundreds of people came and enjoyed live music and refreshments. Two historical marker signs were placed, one near the Mountain Home College Marker near the building, and one by the corner of 4th & College St. for easy viewing.

The Society enjoyed a viewing of the movie classic "Grapes of Wrath" at the Old Time Little Cinema off Hwy 178 as the August meeting substitute. All members are encouraged to attend the next outing to the cinema to enjoy the classics.

Rusty and broken, the old swing sings a wind-rocked tune to the stars


And each creaking note a memory brings of the porch-swing nights of ours.

Willie B. Smith Born October 21, 1869 Dyersburg, Tennessee Died February 16, 1925 Margaret Lonon Smith Born May 26, 1871 Mountain Home, Arkansas Died June 24, 1954

Both buried in Gassville, Arkansas Cemetery

We were united in marrage December 1, 1889, the third day of the same month we started for Texas. Taken the train at Crishman, Arkansas, arrived at Itasca Hill County, Texas, December 7th. We lived there eleven months then we moved back to the dear old state of Arkansas, the place of my birth will always be the dearest place on earth though I may wander far away and still be happy, yet still will I remember the place where in pleasure my childhood was spent.

#### Diary excerpts continued

#### August 15, 1897- Mountain Home, Arkansas.

We lived in Texas three years and on October 1st we moved back to Arkansas. We bought a house and lot in Mountain Home and moved there. Willie B. Smith went into the merchantile business. We stayed there until January 13, 1902. Then we sold out our town property and moved to Harrison, Oklahoma where we bought a lot and built a nice little home and bought a large stock of goods and went into the merchantile business again, but becoming dissatisfied with the country we sold everything for another farm in Ark.

Went back to Texas again for awhile before back again to Arkansas. We arrived here the 5th and moved to our farm, known as the Lindsey farm, having bought it from Dr. Linsey while in Oklahoma. We lived there a little over two years then we sold the farm and moved to this farm that we had not sold.

November 11, 1907 Howe, Grayson County, Texas

Will write again in my diary. We have taken a move again. We left our former home in Baxter County, Arkansas. Rented a place from Mr. McMakin - will try the black mud a year or so. Enough for this time until we make another move, we are not settled as we have not bought a home here.

#### November 11, 1909 - Mountain Home, Arkansas.

Two years ago to the day since last I wrote. Yes we come back. left Texas Nov. 5. 1908 arrived Mtn. Home, Ark, Nov. 21. 1908, got a house and moved Nov. 29th, lived there and sent the kids to Jourdons School until we bought this farm and moved here January 29, 1909. I think we are done moving now for awhile at least we are all satisfied and have good health.

The diary continues with several entries throughout the 50 year span it covers. The diary is currently housed at the Blackburn offices at 4th & College Street. You are invited to stop in for a cup of coffee and a 'good readin' of this precious history of memories past.

#### Visitation for Quinby Smith will be Saturday

Visitation for Quinby Smith, an active member of the local community, will be from noon to 9 p.m. Saturday at Kirby Funeral Home, with the family receiving friends from 7-9 p.m. Mr. Smith died Wednesday (April 12, 1989) at his home. He was 71.

Wednesday (April 12, 1989) at his home. He was 71. An area native, Mr. Smith was born Aug. 25, 1917, at Mountain Home to the late Homer and Rena Pearl Blevins Smith. Mr. Smith was a member of the First United Methodist Church of Mountain Home. He served as Baxter County clerk and circuit clerk from 1947-1956; he was former commander and a member of American Legion Alley White Post 52; served on the Mountain Home School Board for 15 years; was a delegate for the Constitutional Convention in 1970; served as past president of the Arkansas Archeology Society.

Mr. Smith was a charter member and past president of the Baxter County Historicl Society; past president and member of the Mountain Home Rotary Club; past president of the Mountain Home Cemetery Association; certified lay speaker and Sunday school teacher at First United Methodist Church of Mountain Home; former member of the Good Samaritan Advisory Board; former member of Baxter County Day Service Center; member of the Mountain Home Masonic Lodge 225 F&AM; and he was a Shriner. Mr. Smith also served three terms as a justice of the peace on the Baxter County Quorum Court.

Mr. Smith was a retired mail carrier for the United States Postal Service. He married Elizabeth Sowell, who survives him, Aug. 1, 1942, at Little Rock. He was a veteran of World War II serving in the U.S. Army.

In addition to his wife, Mr. Smith is survived by one son, Maj. Lawrence B. Smith who serves in the U.S. Army at the Pentagon in Washington, D.C.; one brother, Rex Smith of Seattle, Wash.; and several nieces and nephews. He was preceded in death by his parents and two sisters.

Services will be at 2 p.m. Sunday at First United Methodist Church with Dr. Joel Cooper, Dr. Ed Matthews and the Rev. Jim Rowland officiating. Burial will be in Mountain Home Cemetery.

Memorials may be made to the First United Methodist Church Building Fund or Hospice of the Ozarks.

Mr. Quinby Smith helped organize the Baxter County Historical Society in 1974 and he served as its President for the first two years. He leaves behind many friends and admirers.

#### Reba Byrd Dearmore, formerly of MH, dies

Visitation for Reba Byrd Dearmore, formerly of Mountain Home, will be from 10 a.m. to 4 p.m. Saturday at Roller Funeral Home, with the family receiving friends from 3 p.m. until service time. Mrs. Dearmore died Monday (Feb. 27, 1989) at Fort Diablo Hospital at Concord, Calif. She was 62.

Services will be at 4 p.m. Saturday at Roller Funeral Home Chapel with the Rev. Bill Mabury officiating. Burial will be in Mountain Home Cemetery with her son, Jonathan Dearmore, and her nephews serving as pallbearers. California services will be at 2 p.m. today at the Walnut Creek, Calif., Presbyterian Church with the Rev. Douglas Van Bronkhorst officiating.

She is survived by her husband, Tom, of the home; one son, Jonathan Dearmore of Pittsburg, Calif.; one daughter, Diana Dearmore of Woodland, Calif.; one brother, Hiram Byrd of Mountain Home; four sisters, Margie Dahlke, Maye Turnbo and Velma Ford, all of Mountain Home, and Josephine Pool of Bossier City, La.; and a host of nieces and nephews. She was preceded in death by her parents and four brothers.

A native of Mountain Home, Mrs. Dearmore was born here April 26, 1926, to the late David M. and Lucy Hargrave Byrd. She and Tom Dearmore were married Nov. 5, 1950, at Mountain Home. She attended Mountain Home Public Schools, graduating in 1944 as class valedictorian. She composed the Mountain Home Alma Mater. She graduated in 1951 from the University of Arkansas at Fayetteville and also attended Central Baptist College at Conway and Arkansas Tech at Russellville. She attended Boston University while her family resided in Cambridge, Mass.

Both she and Mr. Dearmore were descendants of pioneer homesteading families of Mountain Home. She was an organizer of the Arts and Crafts Fair at Mountain Home; past president and an organizer of the Mountain Home Coterie Club; past president of the Arkansas Federation of Women's Clubs, Batesville district; served on the Mountain Home Parks Commission and was instrumental in building the Old Hickory City Park and swimming pool.

An accomplished musician, singer and songwriter, Mrs. Dearmore collected Southern mountain folk songs from pioneer citizens and sang at folk festivals in Arkansas, Maryland and England. She was accomplished on various musical instruments. She also was a poet.

Mrs. Dearmore served as an elder in the Presbyterian Church for many years, most recently at the Walnut Creek, Calif., Presbyterian Church where she also was a member. She served on the San Francisco Presbytery Board, helping guide ministerial students toward ordination. While living in Mountain Home, she was a member of the First Presbyterian Church. She also taught handicapped students at the Walnut Creek Presbyterian Church.

Mrs. Dearmore was a lifelong educator, having taught in schools in Mountain Home, other Arkansas schools, in Maryland and in California until seven years ago. She was named Baxter County Teacher of the Year while teaching in this area.

Her husband was formerly co-editor of The Baxter Bulletin. Presently he is editor of the editorial pages of the San Francisco Examiner and was formerly associate editor of the Arkansas Gazette. He is a former editorial writer for the Washington Star at Washington, D.C.
